

My mission is to make you feel your absolute flawless best! Listening carefully to your needs and preferences, my bridal make-up style is not only natural but lightweight and flawless and designed to work with your individual skin type, be long lasting and photograph beautifully for your special day.

With my calming and friendly personality, I will help guide you through the process from the initial bridal trial to the big day and aim to make it a warm and wonderful experience for you.

I understand that you & your bridal party want to look the very best for your wedding day! My expertise and passion is in creating flawless bridal make-up, but I am also more than happy to provide recommendations for bridal hair for you & the bridal party, having worked alongside some of the best hairstylists in the industry.

On a final note - I have a minimum booking of 4 adult services on the day (e.g. 1 Bride and 3 Bridesmaids). Depending on the size of the booking, I will either work alone or can arrange for another highly recommended make-up artist to join me, all subject to timings on the day.

BRIDAL MAKE-UP TRIAL – PLEASE ALLOW 60 TO 90 MINUTES

Before your trial I will send my FAQ's which should answer any questions you may have and give you my hints & tips.

The trial takes place at my beautiful home make-up studio and is the perfect opportunity to relax and discuss your make-up ideas. Please arrive make-up free (or with make-up on if you want to show me the amount you normally wear).

Please bring along make-up photos and ideas of the looks you like.

At a make-up trial I always work one to one with a Bride. This gives us both the best chance to get to know each other and for me to fully understand the look you want to achieve, without any distractions. However well meaning, it's always difficult for us both to focus when there are questions, comments and recommendations from other members of the bridal party. I am your own personal make-up artist and together we will design the perfect look for you! Any other bridal party trials will be scheduled in later the same day or on a separate day.

Appointments for trials are available Tuesday to Friday (weekends are fully booked with weddings and freelance work) from either 10am or 1pm at my garden studio;

PRICELIST 2021/2022

I have a minimum booking of 4 adult services on the day (e.g. 1 Bride and 3 Bridesmaids).

Wedding bookings are taken up to 12 months in advance and require a £50 deposit to secure the date. This is deducted from your final balance, which is payable 4 to 6 weeks before the wedding date.

Mileage is included in the price up to a 3-mile radius of WF11 9NB and calculated at a rate of 45p per mile thereafter. Please see T&C's below for more details.

TERMS AND CONDITIONS

It is the responsibility of the named person (Bride or Bridal party leader) who made the booking to understand, agree, and accept responsibility for all booking conditions, including all payments due by specified dates. By proceeding to book, you accept that you are entering into a contract and you agree to be bound by these conditions.

DEPOSIT

Bookings are taken up to 12 months in advance. Due to high demand dates get booked up quickly - A deposit of £50 is required at the time of booking to ensure your date is reserved. This deposit is non-refundable and is deducted from the total booking amount. Please note dates will not be reserved until this is received.

MINIMUM BOOKING

Except in exceptional circumstances, I only take one wedding booking per day.

PLEASE NOTE

At the time of booking you will be asked to confirm the number of people who require make-up. Please note there is a minimum requirement of 4 adult services (e.g. 1 Bride and 3 Bridesmaids) on all wedding bookings.

Unfortunately, any reduction in the final numbers after the time of confirmation (enquiry or trial) will still be charged.

MAKE-UP TRIALS

Appointments for trials are available Tuesday to Friday (weekends are fully booked with weddings and freelance work) from either 10am or 1pm at my garden studio; 204 Sutton Lane, Sutton WF119NB.

A trial can be arranged by contacting me direct with your available date(s). Trials are recommended no sooner than 12 weeks before the wedding day.

If you cannot attend a trial within studio appointment times, an evening appointment between 5 and 8pm weekdays can be made available but you will be charged a 25% premium.

In rare circumstances when you are unable to get to the studio for a trial, I may be able to travel out to you on request within studio appointment times. Mileage charges are applicable outside a 3-mile radius of postcode WF11 9NB and charged at 45p per mile.

In the unlikely event of me being unable to attend an original trial date for any reason, you will be notified immediately and an offer of another date will be arranged.

In the event that the bride or any member of the bridal party are unhappy with the trial results, or simply want to try another look please inform me within 7 days from the trial. I am happy to offer additional trials at a discounted rate of £50 for the bride and £30 for the bridal party.

PLEASE NOTE PAYMENT FOR TRIALS IS ACCEPTED IN CASH OR MOBILE BANK TRANSFER BEFORE OR AT THE TIME. All trial payments are non-refundable.

TRAVEL

For bookings which require an early start at a home or venue, I am (and if applicable, my associate stylists) willing to start the journey no earlier than 6am. Where time does not allow travel on the day of the booking, accommodation (Premier Inn or equivalent) must be arranged and all costs, including breakfast, must be paid for before the day itself with the final balance.

For all bookings, mileage charges for me (and if applicable, my associate stylists) are charged separately and are applicable outside a 3-mile radius of postcode WF11 9NB and charged at 45p per mile. This is added to your final balance.

Any parking or toll charges to the value of £5 will be covered however you will be billed for any charges that exceed this amount.

FINAL BALANCE

The final balance, minus your deposit paid is due 4-6 weeks before the wedding date. This will be emailed to you with a breakdown of the costs and should be paid by bank transfer.

Should no payment be received despite a reminder by email or letter by the specified due date (received no less than 2 weeks prior to wedding date) a £25 late payment fee is applicable. I have the right to cancel all services for your wedding date and all fees due will still be payable.

TIMINGS

Allowing for your requirements, the timings on the wedding day will be calculated and you will be given an agreed arrival time.

BOOKING CHANGES

Changes to your booking by adding another person onto your original booking will only be accepted if time and resources allow on your wedding day. Prior notice is required and payment is to be upfront.

Changes made to reduce the number in your bridal party or the services booked will still incur costs payable in the weeks prior to your wedding day. See booking cancellation charges below which will apply to the parties and services cancelled.

If there are any changes to the original booking, the person responsible for booking must inform me in writing as soon as possible. I will try to accommodate changes to dates etc. however this is subject to availability only.

BOOKING CANCELLATIONS

In the unfortunate event that you have to cancel your booking or reduce booking numbers, cancellation charges are as follows:

3 months prior to the wedding day: 50% of remainder of balance due.

1-2 months prior to the wedding day: 75% of remainder of balance due.

1 month or less: Total costs due.

If there are any cancellations to the original booking, the person responsible for booking must inform me in writing as soon as possible. The £50 deposit is non-refundable.

In the unlikely event of me being unable to attend to you, every endeavour will be made to find you another hair / make-up artist of similar standard and qualification. Otherwise full payment of deposit and balance (if paid upfront) will be returned to you in full.

DELAYS ON THE DAY

It is the Brides responsibility to ensure that all members of the bridal party are strictly available at their prearranged allocated time slots. No refund or compensation will be offered for delays caused by other wedding vendors, guests, or members of the bridal party.

If delays due to unforeseen circumstances which are out of my control, such as bad weather conditions or unexpected traffic congestion, compensation will not be offered if services exceed the allocated time and refunds will not be given in the event that one or more services are forfeited as a result.

In the event of extreme weather conditions, where the Met Office has issued a 'Red' warning, I reserve the right to cancel your booking. A full refund of the final balance and deposit will be made, excluding trial costs.

HEALTH & SAFETY

All industry health, hygiene and safety guidelines are strictly followed and I am fully covered with Public Liability insurance.
